



## ICD-10 Testing Schedule

Nevada Medicaid encourages all trading partners and providers to test ICD-10 claim submission prior to the mandated date of October 1, 2015. Trading partners and providers who have questions regarding the test effort or who may be interested in testing with HP Enterprise Services (HPES) can send an email to the ICD-10 mailbox at: [nvicd10testing@hp.com](mailto:nvicd10testing@hp.com).

The last claims cycle will be on September 7, 2015. Claims must be received by 01:00 p.m. Pacific Time (PT) in order to receive an 835 Electronic Remittance Advice (ERA) file for the last testing cycle. HPES will not accept any ICD-10 test claims after this time.

08/03/2015	ICD-10 claims cycle #4	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
08/10/2015	ICD-10 claims cycle #5	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
08/17/2015	ICD-10 claims cycle #6	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
08/24/2015	ICD-10 claims cycle #7	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
08/31/2015	ICD-10 claims cycle #8	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
09/07/2015	ICD-10 claims cycle #9	An 835 will be delivered to the trading partner's mailbox by 5:00 p.m. PT.
10/01/2015	ICD-10 goes live in Production.

**Note:** Trading partners must submit their ICD-10 claims by 1:00 p.m. Pacific Time in order to receive an 835 file for the claims cycle. If your claims are submitted after 1:00 p.m. Pacific Time, they will be held until the following week's claims cycle.
