Modernization: Instructions for Providers and Trading Partners Regarding SNIP Level 4 Edits

The Division of Health Care Financing and Policy (DHCFP) implemented a new, modernized Medicaid Management Information System (MMIS) on February 1, 2019.

Nevada Medicaid has moved compliance editing to validate transactions from Strategic National Implementation Process (SNIP) 3 to SNIP 4 as part of this implementation. The Electronic Data Interchange (EDI) rejections listed below are due to SNIP Level 4 compliance guidelines. The SNIP 4 edits follow business scenarios which are reported in the HIPAA TR3 guides. For example, if the claim is for an accident, the accident date must be present. Edit failures will result in the rejection of the entire transaction set (ST-SE) containing the error(s).

Common SNIP Level 4 Edits for 837P claims:

- **Error Description: 2310C NM109 must be different than 2010AA NM109** – This compliance edit will set when the National Provider Identifier (NPI) used in the 2010AA (Billing Provider) and 2310C (Service Facility Location) are the same. The Service Facility Location is only required when the location of health care service is different than that carried in Loop ID-2010AA (Billing Provider).
- **Error Description: 2310C N3/N4 must be different from 2010AA N3/N4** – This compliance edit will set when the 2310C loop (Service Facility Location) address is used and is an exact match of the 2010AA (Billing Provider) address. The Service Facility Location is only required when the location of health care service is different than that carried in Loop ID-2010AA (Billing Provider).
- **Error Description: 2420C N3/N4 must be different from 2310C N3/N4** – This compliance edit will set when the 2310C loop (Service Facility Location) address is used and is an exact match of the 2420C (Service Facility Location at the detail level) address. The Service Facility Location at the detail level is only required when the location of health care service for this service line is different than that carried in Loop ID-2010AA (Billing Provider) or Loop ID-2310C (Service Facility Location).
- **Error Description: 2310B NM1 must be different from 2010AA NM1** – This compliance edit will set when the NPI used in the 2010AA (Billing Provider) and 2310B (Rendering Provider) are the same. The Rendering Provider is required when it is different than that carried in Loop ID-2010AA (Billing Provider).
