Nevada Medicaid and Nevada Check Up Managed Care Organization (MCO) 2022 Open Enrollment

Managed Care Organization (MCO) Open Enrollment is once a year from **October 1 through October 31** of each year.

Open Enrollment letters will be sent to all Medicaid and Nevada Check Up Managed Care heads of household starting the first week of July 2022, in order for the enrollees to have sufficient time to choose an MCO and return their letter to Nevada Medicaid Attn. MCO Changes, P.O. Box 30042, Reno, NV, 89520 by October 31, 2022, to be effective January 1, 2023.

All MCO change requests received after October 31, 2022, will not be honored. If recipients are not happy with their choice, they will have 90 days from the effective date to make one (1) final MCO change. Once this final change has been processed, recipients will remain locked in the selected MCO until the next open enrollment period, which will be October 1 through October 31 of 2023.

It is important for recipients to update their contact information with the Division of Welfare and Supportive Services (DWSS) as soon as possible to receive all communications regarding their eligibility. Their contact information should include their residence and mailing addresses, phone number or message number, and email address, if available.

Recipients may update their information in <u>AccessNevada.dwss.nv.gov.</u> They will need to create an account and also may sign up for paperless notifications.
