Reminder: Rate Review Surveys for Certain Provider Types

Reminder to [Web Announcement 2817](#): Per Nevada Revised Statutes (NRS) [422.2704](#), the State of Nevada, Nevada Medicaid is required to conduct a rate review for each provider enrolled with Nevada Medicaid at a minimum of every four years. The purpose of this statute is to determine whether the rate of reimbursement accurately reflects the actual cost of providing the service or item. Nevada Medicaid has established a rate review schedule and, at this time, the provider types (PTs) listed below are under review.

Beginning **June 27, 2022**, the enrolled PTs below will be able to access surveys [on the QRR page](#), complete them and return to Nevada Medicaid. The surveys request information regarding Current Procedural Terminology (CPT)/Healthcare Common Procedure Coding System (HCPCS)/Revenue codes billed, and the cost of providing each service/item.

Completed surveys must be returned via email to QRR@DHCFP.nv.gov in Excel® format.

Surveys must be completed and returned by **September 16, 2022**.

As a valued partner with providers, Nevada Medicaid strongly encourages all provider types listed below to complete the survey. Data gathered from provider responses directly contributes to the analysis of current reimbursement rates and may assist in justifying rate adjustments in the future.
