Attention All Providers:

New Novavax COVID-19 Vaccine Code and Administration Codes and Moderna COVID-19 Administration Codes

The U.S. Food and Drug Administration (FDA) has issued an emergency use authorization (EUA) for the Novavax COVID-19 vaccine code and administration codes and the Moderna COVID-19 vaccine administration codes indicated in Table 1. Effective with each EUA date listed in Table 1, the provider types listed in Table 2 may bill the codes indicated in Table 1. Prior authorization is not required.

- Administration procedure codes 0041A and 0042A are billed with vaccine code 91304.
- Administration procedure codes 0091A, 0092A and 0093A are billed with previously established vaccine code 91309.

- Administration procedure code 0113A is billed with previously established vaccine code 91311.

*PT 17 specialties 180, 181 and 182 and PT 47 providers must bill the vaccine administration codes with modifier Q2. The claim will pay according to the established encounter rate and the vaccine administration code will pay at \$0 as the service is included in the encounter reimbursement.

Claims for Novavax procedure codes 91304, 0041A and 0042A for ages 18 and older with dates of service on or after July 13, 2022, through August 18, 2022, and claims for ages 12 or older with dates of service on or after August 19, 2022, through claims processed on or before September 19, 2022, that denied with error codes 3337 (Non-covered procedure due to Centers for Medicare & Medicaid (CMS) termination) or 4801 (No billing rule for procedure) may be reprocessed automatically, if needed. Results of any reprocessed claims will appear on a future remittance advice.

Claims for Moderna procedure codes 0091A, 0092A, 0093A and 0113A with dates of service on or after June 17, 2022, through claims processed on or before September 19, 2022, that denied with error codes 3337 or 4801 may be reprocessed automatically, if needed. Results of any reprocessed claims will appear on a future remittance advice.

When claims are reprocessed or released for adjudication, please be aware that all system and clinical claim editor edits are applicable. As a result, there may be no additional payment, and other claim denials may be received. Providers have the right to appeal denied claims, including those denied upon reprocessing.
