

## December 18, 2023 Nevada Medicaid Web Announcement 3241

## **COVID-19 UNWIND: COVID-19 Administration and Vaccine Procedure Code Emergency Use Authorization and Revocation Updates**

The U.S. Food and Drug Administration (FDA) issued an emergency use authorization (EUA) for the COVID-19 vaccine administration and vaccine procedure codes listed in Table 1 below effective with dates of service on or after September 11, 2023. Prior authorization is not required.

The procedure codes and descriptions of the procedure codes are shown below.

\*PT 17 specialties 180, 181 and 182 and PT 47 providers must bill the vaccine administration codes with modifier Q2. The claim will pay according to the established encounter rate and the vaccine administration code will pay at \$0 as the service is included in the encounter reimbursement.

The FDA has issued an EUA revocation for the COVID-19 vaccine and administration procedure codes listed below. The following procedure codes are not authorized effective with dates of service on or after September 12, 2023.

Providers have the right to appeal denied claims, including those denied upon reprocessing.
