## Annual Medicaid Conference

In 2012, Nevada Medicaid will host conferences in Reno and in Las Vegas. The same information will be presented at all conference sessions.

The main presentation of each conference provides policy and billing information for all providers. After the main presentation, *break-out* sessions provide program-specific information for certain provider types (check the registration form to see if a breakout session is offered for your provider type).

During the break-out sessions, HP Enterprise Services will also present an introduction to electronic claims submission using the Allscripts-Payerpath clearinghouse. This presentation is open to all providers and is offered in lecture format. Hands-on computer training is not available during the conference.



## Provider training

In January 2012, provider training will be a repeat of the November and December training sessions. These sessions will also have an extended Q & A time. These training sessions will help providers after the HP Enterprise Services Provider Web Portal has been live with navigation and user questions.

Beginning in February, the training content for provider training sessions that will be conducted will be announced through web announcements. The content will be changing based on provider feedback and DHCFP program changes. This approach will keep the training material fresh throughout the year. This format will also allow HP Enterprise Services to train providers on the subjects that may be a focus area based on provider needs.

Virtual training will also continue and be available throughout the year. Again, the content will be changing based on provider feedback and DHCFP program changes. These sessions will be announced through web announcements.

Additionally, new Medicaid provider training will be available. Beginning in February, these new Medicaid provider training sessions will be once a month on a scheduled date. These sessions will alternate between Reno and Las Vegas every other month. For example, February new Medicaid provider training will take place in Reno, while March will be located in Las Vegas. Please refer to the 2012 Training Schedule located in this Provider Training Catalog for the new provider training dates and locations. Topics for the new provider training sessions will be posted via web announcements once they are scheduled.

## Individual training

Individual training is available to providers through three different vehicles:

**Phone** – our Call Center can answer most provider questions. However, if more time or explanation is needed, our training team can spend additional one-on-one time on the phone resolving your questions.

**Virtual room** – allows providers and members of the training team to meet in a virtual room and share examples and documents by utilizing the computer and a phone.

**Onsite training** – depending upon your situation, the training team will make arrangements to come to your facility to provide additional training.
