



Waiver for Individuals with Intellectual and Developmental Disabilities

Definition

The Home and Community Based Services for Individuals with Intellectual and Developmental Disabilities is offered to eligible individuals who may require such services in order to remain in their communities and avoid institutionalization.

Nevada's Aging and Disability Services Division (ADSD) operates this waiver program in conjunction with the Division of Health Care Financing and Policy (DHCFP). Therefore, providers and recipients must agree to comply with all ADSD and DHCFP policies.

Prior Authorization

Each recipient is assigned an ADSD Service Coordinator who is responsible for developing the Person Centered Plan (PCP).

A copy of the approved prior authorization must be kept in the recipient's file.

It is important to verify that an approved service authorization is in place before providing services. This can be verified online through the ADSD Electronic Information Management System.

Authorization does not guarantee payment of a claim. Payment is contingent upon eligibility, available benefits, contractual terms, limitations, exclusions, coordination of benefits and other terms and conditions set forth by the benefit program.

Billing Instructions

Providers must submit their invoices to ADSD.

Do not submit invoices to Nevada Medicaid.

ADSD claims submitted to Nevada Medicaid must meet the requirements stated in the claim billing instructions in the Electronic Verification System (EVS) User Manual Chapter 3 Claims and the Transaction 837P Professional claim companion guide, which are posted on the Nevada Medicaid Provider Web Portal at www.medicaid.nv.gov.

Covered Services and Procedure Codes:

The following services are benefits of this waiver program only if the services are 1) identified in the recipient's PCP, and 2) prior authorized by ADSD:

- Non-Medical Transportation: T2003
- Nursing Services: S9123 for RN Private Duty / S9124 for LPN Private Duty / S0281 for Comprehensive Medical Community Support Services / T1001 for Nursing Assessment / T1002 for RN Direct Skilled Services / T1002 U2 (Rural) / T1003 for LPN/LVN Direct Skilled Services / T1003 TN (Rural)
- Nutrition Counseling (Initial assessment): 97802 / 97802 TN (Rural)
- Nutrition Counseling (Re-assessment): 97803 and 97803 TN (Rural)
- Prevocational Services: T2047 (Urban) / T2047 TN (Rural)
- Residential Support Management: T2017 HN (Bachelor's Degree, Urban) / T2017 HN, TN (Bachelor's Degree, Rural) / T2017 HM (Non-Bachelor's, Urban) / T2017 HM, TN (Non-Bachelor's, Rural)
- Residential Support Services: T2016 (Daily Rate, Urban) / T2016 TN (Daily Rate, Rural) / T2017 (Intermittent Services, Urban) / T2017 TN (Intermittent Services, Rural) / T2017 GF (Supplemental Support)
- Supported Employment: T2019 (Urban) / T2019 TN (Rural)

- Behavioral Consultation, Training and Intervention: T2025 HN (Bachelor's Degree, Urban) / T2025 HN, TN (Bachelor's Degree, Rural) / T2025 HO (Master's Degree, Urban) / T2025 HO, TN (Master's Degree, Rural)
- Individual Directed Goods and Services: T2025

In addition to waiver services, recipients eligible under this waiver program are also eligible for full Medicaid benefits.

Jobs and day training (JDT) procedure codes T2019, T2021 and T2047 may be billed on the same day.

Service Limits

The following limits apply to covered services:

- T2003: \$150 per month
- T2019 TG or T2019 TG, TN: 216 hours within a six-month time period per year
- T2025: \$3000 per year
- T2016 with UC Modifier: Variable rates up to \$1800 per day

Hospice and Waiver Services

Recipients enrolled in a hospice program may be eligible for waiver services if the service:

- Allows the recipient to remain in the community, and
- Is palliative or basic self-care, and
- Is not covered under the hospice program.
