Mobile Digital Medicaid Cards Coming January 21, 2022

The new NV Medicaid App will provide Nevada Medicaid recipients/members with a digital Medicaid identification card that can be presented for services under the Medicaid program. The application provides the ability for the recipient to securely share the digital card with a provider, including the option to print if needed for record purposes. Providers are asked to notify your staff that digital cards may be presented by recipients starting January 21, 2022. Nevada Medicaid will begin the rollout of the Nevada Medicaid mobile application that will allow for the sharing of digital Medicaid identification cards to the public on January 21, 2022.

PROCESS FOR CARD UTILIZATION

The process for sharing the card will generate an email to the provider containing a link to the application and a One Time Password (OTP) that will be used to access a copy of the digital card.

The recipient can use the following options for sharing the card to allow the provider to print and save a copy.

- 1) The user can share their own digital ID card to a service provider (i.e., medical doctor) through the "Share Card" icon.
- 2) The Share Card icon is visible on the top right corner on the toolbar when the user is viewing a digital card.
- 3) Before sharing a digital card, an OTP is generated (as shown below). The provider will need the recipient's Medicaid ID# and OTP to view the shared digital card.
- 4) The user enters the service provider's email address as requested to use the email feature. When the service provider receives the email, the OTP is required to launch the NVMedicaid App to view the digital card. The URL for the provider NVMedicaid App site is included in the email. An example of the content of the email to the provider is shown below.

5) The OTP can be used only once and expires after thirty (30) minutes.

The OTP in combination with the recipient's Medicaid ID will allow access to the digital card and provide the option of printing from the web browser. Additionally, the recipient can email their Medicaid ID and OTP to the provider office from the device and that email will contain the URL as well as the OTP.
