2022 Quadrennial Rate Review Report

Per Nevada Revised Statutes (NRS) [422.2704](#), the State of Nevada - Nevada Medicaid is required to conduct a rate review for each provider enrolled with Nevada Medicaid at a minimum of every four years. The purpose of this statute is to determine whether the rate of reimbursement accurately reflects the actual cost of providing the service or item. The 2022 Quadrennial Rate Review (QRR) Report for those providers previously surveyed is now posted on the Division of Health Care Financing and Policy (DHCFP) [QRR webpage](#) under "Quadrennial Reports" on the right side of the webpage.
